

FITTING INSTRUCTIONS FOR CP0197 CRASH PROTECTORS YAMAHA R1 2007 UPPERS







Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

Left-hand side (as you sit on bike)

- Remove fairing
- Remove the engine bolt arrowed above left, do not remove any spacers only bolt.
- Using the mid-length M10 (70mm) bolt and a washer through the block with small dimple as pictured above left, nest block around frame spar with bobbin spigot towards front of bike as shown and tighten
- Install shorter (60mm) bolt (with washer behind head) through crash protector and into bobbin spigot and tighten bolt until you feel some compression from inside the protector. PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE. Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.
- Replace fairing ensuring to connect indicator. Insert bobbin cap so logo is as shown above.



Right-hand side (as you sit on bike)

- Remove fairing
- Remove the engine bolt arrowed above right, do not remove any spacers only bolt.
- Using the longest M10 (80mm) bolts and a washer through the remaining block, nest block around frame spar with bobbin spigot towards front of bike as shown above right and tighten
- Install shorter (60mm) bolt (with washer behind head) through crash protector and into bobbin spigot and tighten bolt until you feel some compression from inside the protector. PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE. Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.
- Replace fairing ensuring to connect indicator. Insert bobbin cap so logo is as shown above.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
